

**Summary of an Annual Investment Report of the  
Myanmar Investment Commission  
2018-2019 FY (1<sup>st</sup>Oct to 30<sup>st</sup>Sep)**

1. In accordance with the section 24 (g) of the Myanmar Investment Law and Rule 148 of Myanmar Investment Rules, Myanmar Investment Commission had submitted the annual report of the status of completion and progress of the investments approved by the Commission in 2018-2019 FY to the second day of the Sixteenth Regular Meeting of Pyidaungsu Hluttaw held on 21 May 2020 through the Union Government. It is, therefore, the Myanmar Investment Commission issues this Summary of Annual Report.
2. For investment facilitation and promotion, Myanmar Investment Commission (MIC) released the necessary notifications which are substitution of members of Sagaing Region Investment Committee (SRIC), Bago Region Investment Committee (BRIC); changing the posting among the members of Bago Region Investment Committee (BRIC) and among the members of Mandalay Region Investment Committee (MRIC) respectively; changing posting the secretary of Ayeyarwaddy Region Investment Committee (ARIC) and amending the Myanmar Investment Law to facilitate investment during 2018-2019 FY.
3. 21 times of the meeting of Myanmar Investment Commission were held during 2018-2019 FY and discussed and decided matters relating to the various investment activities.
4. In terms of foreign investment, MIC permitted (282) new investment projects with the total amount of US\$ 2,764.128 million, and approved increasing investment amount of US\$ 1,394.346 million of existing (97) projects in the Financial Year 2018-19. MIC's total foreign investment including permitted and increased investment was US\$ 4,158.474 million. On the other hand, Thilawa Special Economic Zone Committee permitted (16) new investment projects with the total amount of US\$ 362.280 million. Hence, the total foreign investment amount was US\$ 4520.754 million during 2018-2019 FY.

5. The actual FDI inflow amount per approved investment by MIC was US\$ 2,766.117 million by 28 countries during 2018-2019 FY.
6. In terms of Myanmar Citizens Investment, MIC permitted (169) new investment projects with the total amount of MMK 1,434.873 billion including US\$ 381.638 million and approved MMK 256.459 billion including US\$ 91.647 million from (25) existing projects as increased investment. Hence, MIC permitted citizen investments amount of MMK 1,691.332 billion including US\$ 473.285 million in 2018-2019 FY.
7. The total of (189523) jobs were created, (170330) jobs from (282) foreign investment projects and (19193) jobs from (169) Myanmar citizens investment projects respectively in 2018-2019 FY.
8. To facilitate the MIC's functions, One Stop Service (OSS) was formed under MIC and each and every single member of OSS facilitated their respective duties related investment issues during 2018-2019 FY.
9. The ground field visits were conducted in the (356) projects during 2018-2019 FY. The team consisting of officials from State and Region Offices and One Stop Services led by investment monitoring division conducted ground field visits to (232) projects that were under operation, (121) projects under construction and (3) projects as other matters.
10. Regarding the investment promotion program of MIC, MIC sent delegations to (6) potential countries for (11) times. As investment promotion program in local, (29) events were held across the country. Hence, total (35) events in local and at abroad were completed successfully during 2018-2019 FY. In this regard, MIC releases the summary of annual report for 2018-2019 FY as mentioned above.
